Be a voice for the voiceless

On January 22, 1973, the U.S. Supreme Court in its *Roe v. Wade* and *Doe v. Bolton* decisions legalized abortion on demand. In 1974 the U.S. Catholic Bishops founded the National Committee for a Human Life Amendment, NCHLA, to work to overturn *Roe* and establish the total protection of all human life in law. Today, the threats to human life, born and unborn, not only continue, but have expanded to include attacks on our freedom of conscience. It is wrong for government to force Americans to violate their religious and moral beliefs in respect for life. The need for concerned citizens to speak out is greater than ever.
